## Financial Reports

### Financial secretary's report

We're 3% over for 2010. We have approximately \$310000 in pledges this year, about \$4300 more than last year. We're looking at a budget of \$488000 in budget for this year. We spent \$476000 from the general fund last year. The budget committee would still like \$6000 more.

On the plus side, the Korean Congregation hasn't paid its rent for December—so we will see that income in 2011. Also, the last-minute appeal last Sunday raised an extra \$14000.

### Treasurer's report

The books are closing, but not yet closed, for 2010.

The 2011 budget will be presented in e-mail.

The audit started Sunday afternoon for both 2009 and 2010. It's harder than it could be because our record maintenance is sloppier than it should be. More details and suggestions will be in the final report. They'll be continuing this week and expect to finish before the congregational meeting.

## New business

### Refinancing the mortgage

We've refinanced the mortgage. This reduces our payment by \$433 per month, and cuts the term of the mortgage by eight months. We'll now finish in summer of 2025.

### Windows in the sanctuary

Steve Dougherty tells us that the windows in the sanctuary are peeling outside and the wood beneath is

starting to decay. These are the original windows from 1962, though they have home-built double panes. They aren't well sealed, so we're losing some heat through there. It would cost us ~\$100000 to install new windows, or ~\$53000 to do just the weather side. This plan is for aluminum windows comparable to those now in the Fellowship Hall. They're much nicer than the windows in the new wing, so we wouldn't expect maintenance nightmares like those have been.

We need to find a way to pay for this in the next couple of years—not tonight, but perhaps a capital campaign in the next several years. The Property Committee will be back from its winter quarters in Spring to talk more. The Property committee advises that we must do the weather side by the summer of 2012 or face leaks.

### **Safe church policy**

Alison, Brian, and Jen have documented the practices we already use to keep children safe at St. Paul. These aren't an imagined ideal, but what we already do. Heather asks that we add more about what to do when people violate these guidelines.

**Motion 1.** *We adopt the proposed Safe Church policy as the current policy for the church.*

Alison and Brian will start the maintenance committee for this policy, and work with the Christian Education committee.

### **Haitian support**

University Lutheran and UND Grand Forks are sending a mission and service trip to Haiti this spring. They're looking for financial support.
