Coffee (& Tea)

Motion 1. *St. Paul designates and transfers \$93.09 from the dedicated account P14 to the T7 Equal Exchange account to bring the T7 account to \$0 to balance out the books for 2011. (Equal Exchange coffee and tea purchases and sales are accounted for through T7. By designating money from P14 we will not need to reimburse the dedicated account.*

Our annual meetings in the past have been quite businesslike. Alison Roberts proposes education as one of the areas to focus on—it always seems to need teachers. The Intern project and the Inclusion committee could also use attention. This would also be a good time for Dana Ramish to report on the next steps from his team's work on functional re-alignment.

The Nursery will be available. We'd like Confirmation age youth¹ to participate. Katie Osweiler is working on plans for kids of ages between those. Mark Olson is working on the space: an amplifier, certainly, and the arrangement of chairs. Alison asks us to remember the FM transmitter for some hearing aids. We'll need the Coffee Guild to help us prepare.

Three Council slots will open up (those presently held by Alison Roberts, Dana Ramish, and Katie Corneilson, who are ending their first term each). We'll refer those to the nominating committee.

Mark promises an agenda before the meeting.

Pastoral reports

Pastor Goodman speaks about an encounter he had after church on Sunday. A newly-expecting mother suggested that we might rename this the Lutheran Church of the Fertility Goddess; at least four babies are now on the way. Carl Carlson's funeral was this month. Al Landberg is having a tough patch of pneumonia leading to other problems. He's now back home with hospice care. The Synod has asked for help with a call process this coming week—the candidate will be running part of both services as a guest pastor, and their call committee will be here as guests². Then Daniel Eisenberg, our intern-presumptive, will be here the following week. Last year's intern, C.J. Stratton, is a finalist at a large Lutheran church in Fargo—thousands of members and a thousand in the pews at each service. She'll be one of three new pastors coming in for the next two years as a sort of postdoc funded by the Lilly Endowment.

It turns out that the report due to the Lilly Fund about Pastor Henry's sabbatical several years ago was never filed. She and Pastor Goodman will see that it's filed late rather than never—and before we hit the deadline of having to pay the money back.

He's investigating a subsidized solar-power system for the roof.

Vicar Soltis reports that her project is going well. She proposes that having the council members do the work of calling people would be good. The entire Council announces that they don't like making or receiving phone calls.
